Installing any kind of security equipment on a property without first having a security risk assessment, is like driving a car blindfolded. You might escape disaster once, but your luck will run out.




WHAT WE DO



WHY YOUR SECURITY FAILS YOU

We need our clients to understand WHY security fails.

Broadly speaking there are two types of crime. Outer and inner crime, meaning crime committed by people outside the property and those inside the establishment. During our assessment we contemplate the impact of both types of crimes. The starting point of effective security is knowledge. Only then is one able to make informed decisions about the correct security measures to implement. An additional impediment to effective security is the proper preservation of evidence in the event of a crime.


